# From the Rabbi's Desk:

As December begins, the fate of reproductive rights in this country hangs in the balance. On December 1, the Court will hear arguments in Dobbs v. Jackson Women's

Health Organization, the challenge to a Missouri law banning abortion at 15 weeks. If the Court overturns Roe, nearly 50 years of women's ability to make one of the most complex, personal and painful decisions about their own reproductive health will be taken away, certainly in the 22 states that stand ready to outlaw abortion immediately. Nearly 40 million American women of reproductive age live in states that have demonstrated hostility to abortion rights.

On December 1, Jews will light the fourth Hanukkah candle. Hanukkah celebrates the victory of the Maccabees for religious freedom. In the emotional debate about abortion, religious freedom is a principle that often gets lost. Laws prohibiting and restricting access to abortion are in fact imposing a particular religious view—that life begins at conception—upon this nation. That is not the Jewish view. Therefore, such laws violate my religious freedom as protected under the First Amendment.

Given all that is at stake, it is important to understand the Jewish view on abortion: not only does Judaism permit abortion; at times, Judaism demands abortion as the mother's life takes precedence over that of the fetus.

Judaism teaches that life begins at birth. We learn this in Exodus 21:22 which describes the case for damages when a pregnant woman miscarries as a result of being pushed. The responsible party must pay damages. If that pregnancy loss would have been considered murder, the penalty would have been life for life.

The Mishnah, codified in 200 CE, clarifies that life begins when the largest part of the fetus emerges in birth. Up until that point, if the mother's life is in danger, one must abort. As Jewish law develops, opinions vary on situations when abortion is permitted, primarily based on the mother's physical, psychological and emotional well-being. Even as the rabbis recognized stages in fetal development, they also understood the fetus as a life in development. Thus, a Talmudic ruling approves of violating Shabbat to save a fetus on the principle of *pikuah nefesh* (saving a life) though it is not yet a life.

A fetus in not a separate entity. In Jewish law, a fetus is considered part of the woman, so that if a pregnant woman converts to Judaism, the baby is Jewish. A fetus has no rights or separate status.

Our Reform movement has consistently taken strong stands in support of reproductive choice and access to reproductive health care. Reproductive rights are also a matter of economic and racial justice. Those with financial means will always have access to abortion. It is the poor whose health and lives are most at risk and black women comprise the highest percentage of those obtaining abortions.

While we are fortunate to live in one of fifteen states that have passed legislation protecting reproductive health, we cannot "stand idly by the blood our neighbor." Pro-choice organizations are turning their energies towards advocacy for legislation that will codify these rights into law throughout the nation. Two bills have already been introduced in Congress: *The Women's Health Protection Act*, which passed in the House, would protect access to abortion care and *The Equal Access to Abortion Coverage in Health Insurance Act* would permanently end insurance coverage bans.

As we light our Hanukkiot for the final nights of Hanukkah, let us draw strength from the courage of the Maccabees to defend our rights—to follow the teachings of our faith, to have control over our bodies, to make our own choices about the most important decisions in our lives.

# President's Message: Selected Updates

When my term began, I enumerated objectives to help prepare Vassar Temple for its next 175 years. Admittedly, especially in light of the pandemic, my goal has been downsized from finishing these to at least getting each of them

started. Empowered by my experience at the URJ's Scheidt Seminar, and buoyed by my small Presidents' Network group, I continue to endeavor to be a "change agent" in our community.



#### Following are three important updates.

Social Media initiative. I am thrilled to announce that, through the generosity and vision of the new Gluck Fund, we have engaged a professional consultant who will develop a robust presence on social media and support us with various other means to increase our outreach. The Jewish-Adjacent Task Force was created by the Board in accordance with the authority given in our Bylaws to form a group to address an identified need. In response to significant changes in demographics and our movement's interest in increasing inclusivity, the goal of this project is to recommend to the Board policies that reflect the Reform vision along with Vassar Temple history and practice, through a process of learning and discussion. With the guidance of our Rabbi, the Task Force will use URJ and other materials for thoughtful discussion and clarification of membership, ritual, and governance questions. The group will engage in honest, open dialog in a safe environment where different points of view are respected and explored without preconceived outcomes. Participation will include representation from the spectrum of Temple membership.

A new Cemetery Committee is comprised of several highly motivated members who stepped up for this important work. A great deal is already being accomplished. A substantial cleanup of both sides on Lagrange Avenue was completed by a professional firm. If you have visited periodically, you will notice the significant improvement. We anticipate further enhancements. A broken fence in the oldest section. dividing our property from that of Congregation Schomre Israel, was removed (and the cost shared), allowing us to give needed respect to that historic section and repair old monuments that were knocked over. Individuals are working on updating maps, exploring software for cemetery records, and gathering information on remaining members of the Hebrew Fraternal Benevolent Society in order to determine available space. With the support of Rabbi Altman, we are tackling a complete review of cemetery policies. And much more. Additional participants are welcome.

Change is very hard. I am so grateful to our trustees, clergy, staff, chairs, volunteers and all of you for coming along on this journey.

#### Religious School Update

We begin this month in the midst of Hanukkah and we look forward to welcoming parents to join with their children for some fun Hanukkah activities on Sunday, December 5. Appropriately, we are in Unit 3 of the ShalomLearning curriculum that focuses on the value of *gevurah*, strength. When thinking about *gevurah*, we generally think of physical strength and courage, like that of the Maccabees and how they dared to stand up and fight back against the Assyrians. Our curriculum takes students in a different direction, that of spiritual courage: standing up for what is right, daring to go against the tide of peer pressure, taking risks to defend others, especially those who are different from you. Building on the prior unit of *b'tzelem Elohim*, the Jewish belief that everyone is created in the image of God, the students explore teachings such as "love your neighbor as yourselves."

All families with children are also invited to join a Community Hanukkah Celebration—A Hanukkah Story Walk on Sunday, December 5 at 4pm. Vassar Temple will join with the other area synagogues, PJ Library and Federation in this fun-filled afternoon. Weather permitting, it will take place in front of Temple Beth-El on S. Grand Avenue; in case of inclement weather, we will be in their social hall (masked and maintaining social distance). We will conclude at 5pm with songs and lighting the Hanukkiah.




